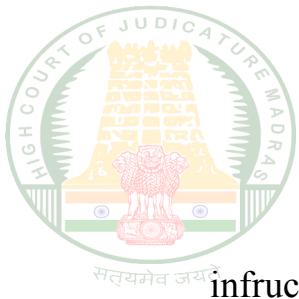

ORDER

2.When the matter is taken up for hearing, Mr.Amjadkhan, learned counsel appearing for the third respondent/Teachers Recruitment Board submitted that the respondents have already published the reserve list and therefore, the relief sought in the writ petition has become
