The prayer in this writ petition is to issue a Writ of Mandamus, directing the respondents to consider the petitioner's representation dated 19.10.2025.

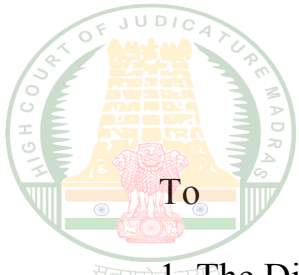
