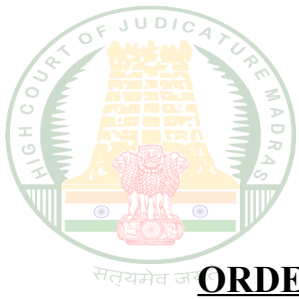

PETITION FOR BAIL Under Sec.483 of BNSS

PRAYER :- To enlarge the petitioner on bail in S.C.No.279 of 2025 on the file of the II Additional District and Sessions Court, Thoothukudi, for the offences under Sections 3(5), 126(2), 296(b), 103(1), 351(3) BNS @ 191(2), 191(3), 3(5), 126(2), 296(b), 103(2), 351(3), 61(2) BNS pending investigation on the file of the respondent Police.

ORDER : The Court made the following order :-

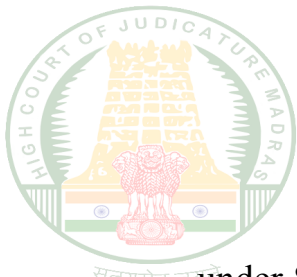

The petitioner, who is facing trial in S.C.No.279 of 2025 on the file of the II Additional District and Sessions Court, Thoothukudi District, for the offences under Sections 3(5), 126(2), 296(b), 103(1), 351(3) BNS @ 191(2), 191(3), 3(5), 126(2), 296(b), 103(2), 351(3), 61(2) BNS in Crime No.248 of 2025 on the file of the respondent Police, seeks bail.

2. The case of the prosecution is that due to previous enmity between the deceased and the accused persons, on 01.06.2025, the petitioner, along with other accused persons, waylaid the deceased, abused him in filthy language, and assaulted him with an aruval, which resulted in his death. Hence, the complaint

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offences as alleged by the prosecution. He further submitted that the petitioner is ready and willing to abide by any conditions which may be imposed by this Court and he is in judicial custody from 02.06.2025. Hence, he seeks bail to the petitioner.

4. The learned Additional Public Prosecutor submitted that there is one previous case pending against the petitioner herein for the offence

under Sections 326 and 306(ii) IPC. Hence, he opposed the grant of bail to the petitioner.

5. Taking into consideration of the facts and circumstances of the case and considering the nature of offence and also considering the period of incarceration suffered by the petitioner, this Court is inclined to grant bail to the petitioner, subject to the following conditions:

6. Accordingly, the petitioner is ordered to be released on bail on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the II Additional District and Sessions Judge, Thoothukudi and on further conditions that :-

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the petitioner shall stay at Trichy and report before the Inspector of Police, Trichy Cantonment Police Station, Trichy, daily at 10.30 a.m., until further orders. No request for relaxation shall be entertained in the next three months.

[c] the petitioner shall not abscond either during investigation or trial.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
