Without expressing any opinion on the merits of the matter, the respondents 1 and 2 are directed to conduct enquiry on the objection submitted by the petitioner while surveying and demarcation of the property comprised in Survey Nos. 17/5 and 17/6 measuring to an extent of 00.70.00 Ares and 00.22.00 Ares respectively situated at A.Kalappur Village, Singampunari Taluk, Sivagangai District and pass orders on merits and in accordance with law, after giving opportunity of hearing to the petitioner and the counter parties.
