ORDER : The Court made the following order :-

The petitioner / Accused, who was arrested and remanded to judicial custody on 06.05.2026 for the offences punishable under Sections 296(b), 127(2), 75(1), 351(2), 49 of BNS, 2023 and Section 4 of TNPHW Act, 2002 in Crime No. 313 of 2026 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that on 05.04.2026 at about 10.30 a.m., A2 brought the defacto complainant to the petitioner's finance shop for availing loan and however, after entering into the shop, A2 locked the shop and A1 attempted to misbehave with her. When it was informed to the defacto complainant's husband, he condemned the same and A2 to A4 came to the house of the defacto complainant and abused her in filthy language and threatened her with dire consequences. Hence the case.

3. The learned counsel appearing for the petitioner would submit that the petitioner is innocent and he was falsely implicated in this case and he has not committed any offence as alleged by the prosecution. He would further submit that he has been arrested and remanded to judicial custody on 06.05.2026. Therefore, prayed to grant bail for the petitioner.

4. The learned Additional Public Prosecutor appearing for the respondent would submit that based on the complaint lodged by the defacto complainant, the case has been registered under Sections 296(b), 127(2), 75(1), 351(2), 49 of BNS, 2023 and Section 4 of TNPHW Act, 2002 in Crime No. 313 of 2026. He would further submit that the petitioner has three previous case, out of which one case was disposed of. He would further submit that the investigation is pending and the offences are grave in nature and hence, he strongly opposed to grant bail to the petitioner.

5. This Court heard both sides and perused the materials

6. Considering the rival submissions made by the learned counsel on either side, nature of offence, and considering all the facts and circumstances of the case and also considering the period of incarceration undergone by the petitioner, this Court is inclined to grant bail to the petitioner subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Uthamapalayam, and on further conditions that:

[b] the petitioner shall report before the respondent police on every Monday at 10.30 a.m., until further orders;

[c] the petitioner shall not commit any offence

similar to the offence of which he/she is accused, or suspected, or of the commission of which he/she is suspected;

[d] the petitioner shall not abscond either during investigation or trial;

[e] the petitioner shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade her from disclosing such facts to the Court or to any police officer or tamper with the evidence;

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].
