The petitioner / A6, who was arrested and remanded to judicial custody on 29.04.2024 for the offences punishable under Sections 8(C) r/w.

2. The case of the prosecution is that the petitioner along with other accused were found in illegal possession of 200kgs of ganja. Hence the case.

3. The learned counsel for the petitioner would submit that the respondent police has registered a false case against the petitioner and he has not committed any offence as alleged by the prosecution. He would further submit that the petitioner has been arrested and remanded to judicial custody on 29.04.2024. He would further submit that mandatory provisions under Sections 42,50,52A and 57 of NDPS Act has not been complied with. Hence, he prays to grant bail to the petitioner.

4. The learned Government Advocate(Crl.Side) appearing for the respondent would submit that the petitioner along with other accused were found in illegal possession of 200 kgs of ganja which is a commercial quantity. He would further submit that one previous case is pending against the petitioner. Hence, he opposed to grant bail to the petitioner.

Considering the rival submissions made by the learned counsel on either side and considering the nature of offences and also taking into consideration the quantity of contraband involved in this case and the fact that one previous case is pending against the petitioner, this Court is not inclined to grant bail to the petitioner at this stage.

7. In the result, the petition stands dismissed.
