Muthumariyamman Temple, situated at Velloor Village on the basis of his representation dated 17.04.2026.

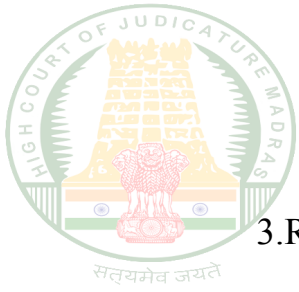
