ORDER

The present Writ Petition has been filed for the issuance of a Writ of Mandamus, directing the respondents to change the survey number in T.S.L.R as T.S.No.41 Part and 42 Part instead of T.S.No.41 with correct measurements in Ward-1, Block No.0008, Pandamangalam Village, Abishekapuram Zone, Tiruchirappalli West Taluk, Tiruchirappalli District, by considering the petitioner's representation dated 11.04.2026 in the light of correlation certificate dated 01.04.2026 issued by the third respondent within the period that may be stipulated by this Court.

2. The contention of the petitioner is that the subject property has been erroneously recorded as T.S.No.41 in the revenue records. According to the petitioner, the correct survey particulars ought to be reflected as T.S.No.41 Part and T.S.No.42 Part. Therefore, the petitioner has approached this Court seeking a

direction to the respondents to effect necessary corrections in the relevant records.

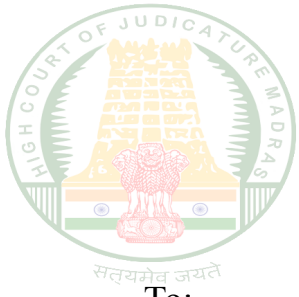
