PETITION FOR BAIL Under Sec.483 of BNSS

PRAYER :-

For Bail in Cr.No. 451 of 2024 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner / Accused, who was arrested and remanded to judicial custody on 10.07.2024, for the offences punishable under Sections 8(c) r/w. 20(b)(ii)(C), 25 & 29(1) of NDPS Act, in Crime No.451 of 2024 on the file of

the respondent police, seeks bail.

2. The case of the prosecution is that on secret information on 10.07.2024 the respondent police went to the scene of occurrence, where they found the accused persons are in possession of 21 kilograms of ganja. Hence, the case.

3. The learned counsel appearing for the petitioner would submit that the petitioner is innocent and he was falsely implicated in this case and he has not committed any offence as alleged by the prosecution. Though the quantity involved is commercial quantity, no contraband was recovered from this petitioner and the entire contraband have been recovered from A1. This petitioner has been implicated on the basis of the confession statement of the co-accused. Co-accused namely A1, A4, A5, A6 and A7 in this case have been released on bail. Hence, he prayed bail for the petitioner.

4. The learned Government Advocate (crl. Side) appearing for the respondent would submit that the offence are grave in nature. The entire contraband has been recovered from A1. The petitioner has 10 previous cases. Out of which two cases were disposed of. On the basis of the confession statement of the co-accused this petitioner has been implicated in this case.



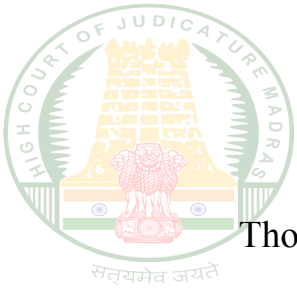

Investigation in this case has been completed and charge sheet has also been filed before the concerned Court. Hence, he opposed the grant of bail to the petitioner.

5. This Court heard both sides and perused the materials available on record.

6. Considering the rival submissions made by the learned counsel on either side, considering the nature of charges levelled against the petitioner, the quantity involved in this case is commercial quantity, the contraband was recovered from A1 and no contraband has been recovered from this petitioner, only on the basis of the confession statement of the co-accused this petitioner has been implicated in this case, co-accused namely A2, A4, A5, A6, A7 have also been released on bail, though according to the prosecution the petitioner has 10 previous cases and out of which two cases were disposed of, in all other cases, the petitioner was granted bail, they are not similar kind of offences and considering the period of incarceration undergone by the petitioner, this Court is inclined to grant bail to the petitioner subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten

Thousand only) with two sureties each for a like sum to the satisfaction of the learned **I Additonal District Judge, Special Court for NDPS Act Cases, Madurai**, and on further conditions that:

[b] the petitioner shall report before the learned **I Additonal District Judge, Special Court for NDPS Act Cases, Madurai**, at **10.30 a.m., on all working days, until further orders:**

[c] the petitioner shall not commit any offence similar to the offence of which he/she is accused, or suspected, or of the commission of which he/she is suspected;

[d] the petitioner shall not abscond either during investigation or trial;

[e] the petitioner shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade her from disclosing such facts to the Court or to any police officer or tamper with the evidence;

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned

Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 51730].

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
