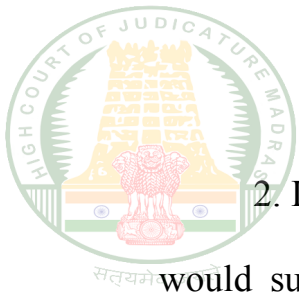

2. Learned Standing Counsel appearing for the 1st respondent Corporation would submit that the 1st respondent will consider the representation of the petitioner, inspect the site in question and if there is any unauthorised construction therein, after hearing both sides, appropriate action will be taken for removal of the same.

3. In such a view of the matter, let the 1st respondent make an inspection of the place in question, hear both sides and if any unauthorised construction is found, the 1st respondent shall take steps to remove the same after giving opportunity to both sides. Such an exercise shall be completed within a period of three months from the date of receipt of a copy of this order.

4. With the above direction, the Writ Petition is disposed of. No costs.
