This criminal miscellaneous petition has been filed seeking to suspend the sentence imposed on the petitioner by the Sessions Judge, Magalir Neethi Mandram, Fast Track Mahila Court, Theni, in S.C.No.14 of 2021, dated 29/09/2024 and to enlarge the petitioner on bail pending disposal of the criminal appeal.

2.The petitioner stands convicted and sentenced as under:-

| 302 IPC        | Life Imprisonment        | Rs.2,000/-, in default to undergo 1 Year SI    |
| 294(b) IPC     |                          | Rs.2,000/-, to default to undergo one month SI |

3.Heard the learned counsel on either side and perused the materials available on record.

4.The petitioner has failed to make out a *prima facie* case for grant of suspension of sentence, hence we are of the opinion that it is not a fit case for grant of suspension of sentence to the petitioner.
