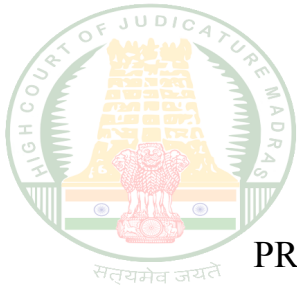

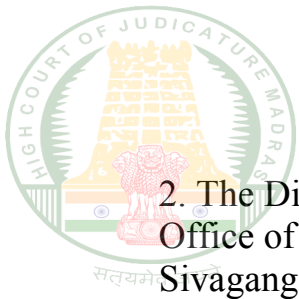
3. With the above direction, the Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
