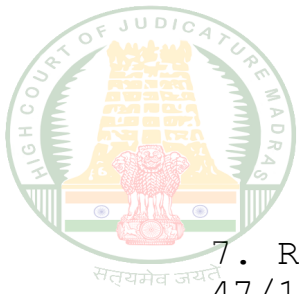

seeks anticipatory bail.



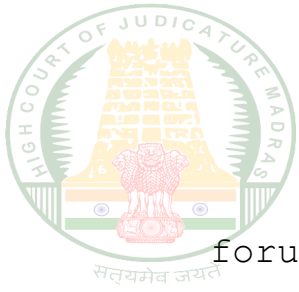
