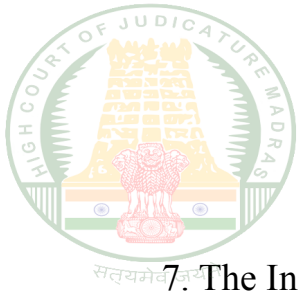

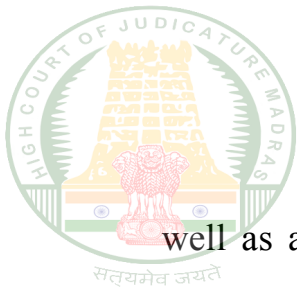

connection with the festival of Sree Mahakaliamman Temple situated at Malvarpatti, Vendasandur Taluk, Dindigul District.

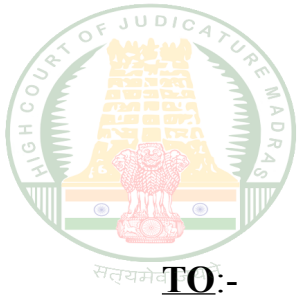
