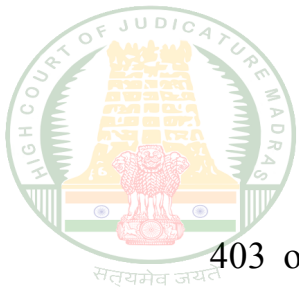
### **ORDER**

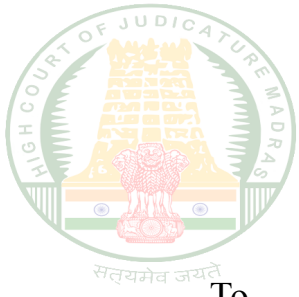

In the said circumstances, this writ petition is allowed and the respondent is directed to pay interest at the rate of 6% per annum for the belated payment of the petitioner's terminal benefits, including Provident Fund, Gratuity, Terminal Leave Salary and Commuted Value of Pension and other monetary benefits from the date of his retirement till the date on which the terminal benefits are paid to the petitioner. The respondent is further directed to comply with the said direction as expeditiously as possible, at any rate, within a period of FIVE MONTHS from the date of receipt of a copy of this order.
