ORDER

2. The learned counsel for the petitioner submitted that the petitioner is one of the committee members of 5th day Mandagapaditharar who is organizing the village festival i.e., Muthumariyamman Temple Festival. The said festival has been celebrated for several years. To prevent any law and order issues or untoward incidents, the petitioner had requested the respondent police to provide adequate police protection by way of representation dated 08.05.2026. Since the same was not considered, the petitioner is before this Court.
