This Criminal Miscellaneous Petition is filed to modify the condition imposed upon the

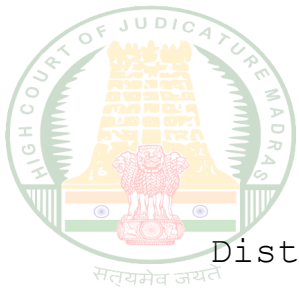
