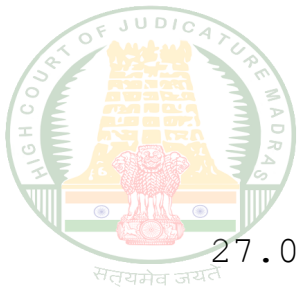

This Criminal Miscellaneous Petition is filed to modify the condition imposed upon the petitioner in Crl.M.P.No.85 of 2026 dated

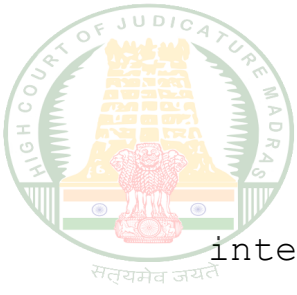
