The petitioner is directed to be enlarged on bail on executing a bond for Rs.25,000/- (Rupees Twenty Five thousand only) with two sureties, each for a like sum to the satisfaction of the II Additional District and Sessions Court, Trichy.

The other conditions imposed by this Court shall stand as it is.

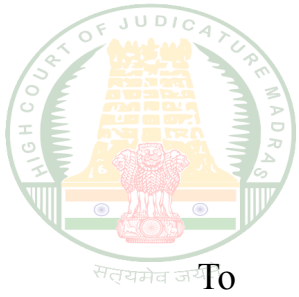
4. This Petition stands disposed of accordingly.
