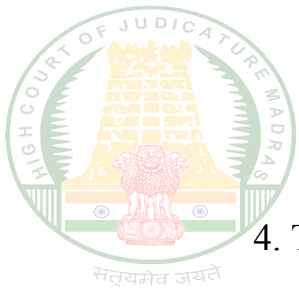

ORDER

The present petition has been filed by the Accused Nos.2 & 4, 5 to 7 in Crime No.165 of 2026, on the file of the second respondent police seeking a direction as against the trial Court to consider the bail application of the petitioners on the same day of surrender.

2. Since the 2nd Petitioner/Accused No. 4 has already been arrested, this petition stands dismissed as against the 2nd petitioner/Accused No. 4.

3. Considering the averments in the petition, there shall be a direction to the Special Court for trial of cases under SC/ST (POA) Act, Karur, to consider the bail application of the petitioner Nos.1,3 to 5/Accused Nos.2, 5 to 7 on the same day of surrender in Crime No.165 of 2026, after giving due opportunity to the defacto complainant.

4. The petitioner Nos.1,3 to 5/Accused Nos.2, 5 to 7 shall surrender before the concerned Court on or before **30.06.2026**.

5. With the above said observations, this Criminal Original Petition stands partly allowed.
