ORDER

The petitioner herein, who worked as a Child Welfare Organizer, retired from service on 31.10.2007 and has been in receipt of special pension at the rate of Rs.2,000/- per month. The petitioner claims to have approached the respondent by submitting a representation dated 20.01.2025 requesting for payment of enhanced pension. But, the same has not been considered by the respondent and hence, the petitioner has approached this Court by filing the present writ petition seeking a direction to the respondent to consider her representation.

2. Mr.M.Dinesh Hari Sudarsan, learned counsel for the Government, who takes notice for the respondent, on instructions, submitted that the Government has already issued orders enhancing the pension amount *vide* G.O.Ms.No.41, Social Welfare Department, dated 13.02.2026 and certain clarifications are sought for from the Government for implementing the said Government Order. Further, he submitted that the claim of the petitioner can be considered by the respondent in terms of the said Government Order.
