This criminal miscellaneous petition has been filed seeking to suspend the sentence imposed on the petitioner by the Special Court (POCSO Act cases), Virudhunagar at Srivilliputhur, in Special S.C.No.76 of 2020, dated 21/11/2022 and to enlarge the petitioner on bail pending disposal of the criminal appeal.

2.The petitioner stands convicted and sentenced as under:-

5(l) r/w (5) of POCSO Act	Life Imprisonment	Rs.1,00,000/-, in default to undergo 2 Years SI
506(i) IPC	2 Years RI	Rs.10,000/-, to default to undergo one year SI

3.Heard the learned counsel on either side and perused the materials available on record.

4.The petitioner has failed to make out a *prima facie* case for grant of suspension of sentence, hence we are of the opinion that it is not a fit case for grant of suspension of sentence to the petitioner.
