This criminal miscellaneous petition has been filed seeking to suspend the sentence imposed on the petitioner by the Sessions Judge, Fast Track Mahila Court, Kanniyakumari at Nagercoil, in S.C.No.61 of 2014, dated 16/09/2019 and to enlarge the petitioner on bail pending disposal of the criminal appeal.

2.The petitioner stands convicted and sentenced as under:-

302 IPC	Life Imprisonment	Rs.15,000/-, in default to undergo 1 Year RI

392 IPC	7 Years RI	Rs.10,000/-, in default to undergo one Year RI
