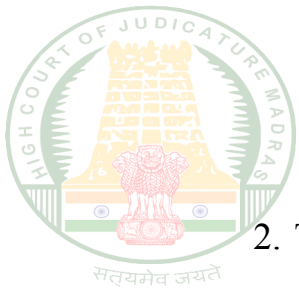

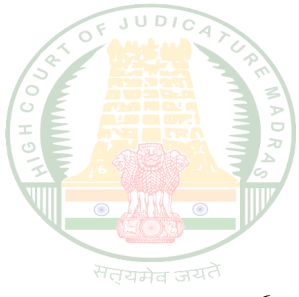
“6.
