2.According to the learned counsel for the petitioners, due to lack of communication, the order was not communicated to the petitioners herein and therefore, they could not surrender before the Court.

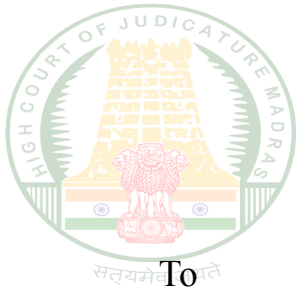
3.Being satisfied with the reasons, time is extended till 13.07.2026 to surrender before the concerned Court. It is made clear that no further extension of time would be granted.
