2. Heard the learned counsel for the petitioner and the learned counsel for the Government of Tamilnadu appearing for the respondents.

3. This Court, without expressing any opinion on the merits of the case, is directing the respondents to consider and pass orders on the petitioner's representation dated 26.03.2026, after issuing notice to the
