ORDER

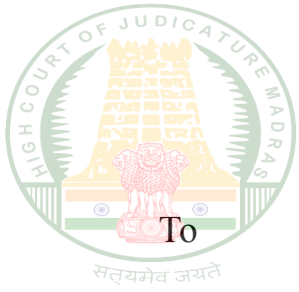
The present petition has been filed by the petitioner seeking a direction as against the respondent not to harass him on the guise of enquiry.
