PETITION FOR BAIL Under Sec.483 of BNSS

PRAYER :-

For Bail in Cr.No. 227 of 2026 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner / Accused, who was arrested and remanded to judicial custody on 30.05.2026, for the offences punishable under Sections 191(2), 191(3) of BNS and 25(1-A) of Arms Act, in Crime No.227 of 2026 on the file

of the respondent police, seeks bail.

2. The case of the prosecution is that on 28.04.2026 at about 12.15 hours, in the midnight when the defacto complainant returned to home, the accused persons came there with dangerous weapons, sword, beer bottle and long sticks, some of the accused came in a two wheeler and raise the accelerator and threatened the public. Hence, the case.

3. The learned counsel appearing for the petitioner would submit that the petitioner is innocent and he was falsely implicated in this case and he has not committed any offence as alleged by the prosecution. Hence, he prayed bail for the petitioner.

4. The learned Government Advocate (crl. Side) appearing for the respondent would submit that the offence are grave in nature. The petitioner along with other accused persons in possession of deadly weapons and threatened the public in the night hours. The petitioner has four previous cases. No one was sustained injuries in this case. Investigation is still pending. Hence, he opposed the grant of bail to the petitioner.

5. This Court heard both sides and perused the materials available on record.

6. Considering the rival submissions made by the learned counsel on either side, considering the nature of charges levelled against the petitioner, nobody was sustained injuries in this case, though the prosecution has stated that the petitioner has four previous cases, all the cases are not similar in nature and in all cases, he was granted bail and considering the period of incarceration undergone by the petitioner, this Court is inclined to grant bail to the petitioner subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned **Judicial Magistrate, Sivakasi**, and on further conditions that:

[b] the petitioner shall report before the respondent police, daily at 10.30 a.m., for a period of thirty days, thereafter as and when required for interrogation:

[c] the petitioner shall not commit any offence similar to the offence of which he/she is accused, or suspected, or of the

commission of which he/she is suspected;

[d] the petitioner shall not abscond either during investigation or trial;

[e] the petitioner shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade her from disclosing such facts to the Court or to any police officer or tamper with the evidence;

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 51730].

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
