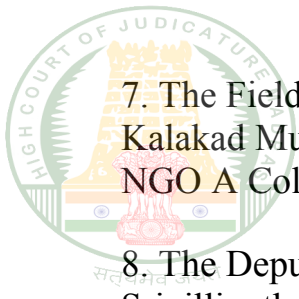

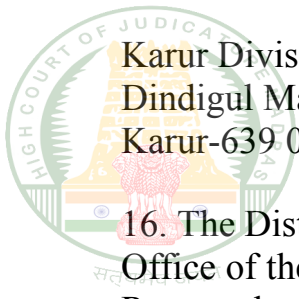

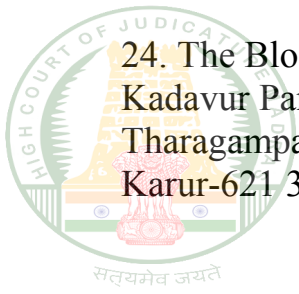

to the forest protection and wildlife offenses, after getting appropriate orders from the

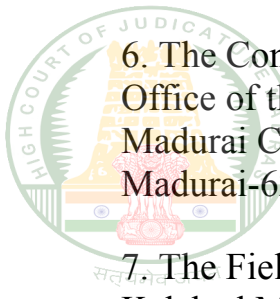

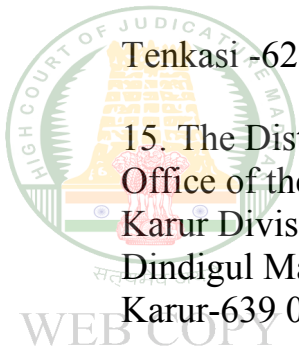

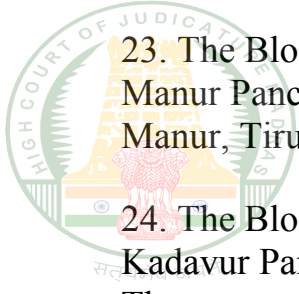
