ORDER

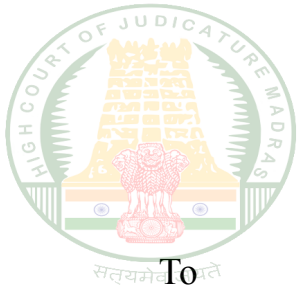

2. Considering the averments in the petition, there shall be a direction to the learned *Sessions Judge, II Additional District and Sessions Court for PCR Cases, Tirunelveli*, on or before **10.07.2026** and the learned Trial Court shall consider the bail application of the petitioners in Crime No.363 of 2026 on the file of the second respondent police and accept their surrender on the same day, after giving due opportunity to the defacto complainant.
