respondent and quash the same as illegal as against these petitioners are concerned.

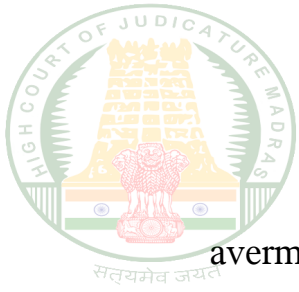
