4. Learned Special Government Pleader, appearing for the official respondents, submits that the representation of the petitioner's would be

In view of the above submissions, without expressing any opinion on the merits of the matter, this writ petition is disposed of with a direction to the respondents 1 and 2 to consider the petitioner's representation dated 30.04.2025 on merits and in accordance with law, after giving notice to the impleaded respondents as well as interested parties and pass appropriate orders within a period of eight weeks from the date of receipt of a copy of this order. Needless to say, if any rival claims, the same shall be subject to the jurisdiction of the civil Court. There shall be no order as to costs.
