3. The petitioner submitted a representation on 13.10.2021 to the respondents for issuance of joint patta. However, no action has been taken on the said representation. Hence, the present writ petition has been filed.

In view of the above submissions, without expressing any opinion on the merits of the matter, this writ petition is disposed of with a direction to the respondents 1 and 2 to consider the petitioner's representation dated 13.10.2021 on merits and in accordance with law, after giving notice to the interested parties and pass appropriate orders within a period of twelve weeks from the date of receipt of a copy of this order. Needless to say, if any rival claims, the same shall be subject to the jurisdiction of the civil Court. There shall be no order as to costs.
