Today, when the matter is taken up for hearing, the learned Additional Government Pleader appearing for the respondents 1 to 5, by referring to the proceedings of the fourth respondent dated 05.01.2026 submits that the petitioner's representation for regularization has been rejected on the ground that the post is only a part-time Vocational Instructor.

3. Recording the above submission, this writ petition is closed. No Costs. Consequently, connected miscellaneous petition is closed. The respondents are directed to furnish a copy of the proceedings dated 05.01.2026 to the petitioner, enabling him to work out his remedy in the manner known to law.
