2.The learned Additional Government Pleader appearing on behalf of the respondents submits that pursuant to the order passed by this Court on 20.11.2024, the respondents have conducted enquiry and found that there is no encroachment as alleged in the writ petition. He further submits that the present contempt petition is filed as if the order of this Court had not been complied with.
