2.Learned Special Government Pleader appearing for the official respondents has no objection.

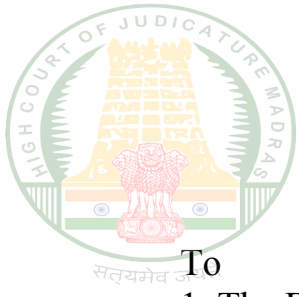
