2. Heard the learned counsel for the petitioner, learned Special Government Pleader for the respondents 1 to 6, learned Government Advocate appearing for the 7<sup>th</sup> respondent and the learned counsel for the 8<sup>th</sup> respondent.

3. The learned counsel for the petitioner would submit that the representation made way back in the year 2022 was not acted upon.

4. Learned counsel for the 8<sup>th</sup> respondent would submit that with regard to the dispute, civil suits are pending before the civil Court in OS No.3/2019 (for recovery of possession) and OS No.199/2025 (for declaration).

5. In the event of there being rival claim, any action by the respondents in the present writ petition for survey shall be subject to the outcome of the civil suits. Further, it is also informed that a petition is already filed for appointing an Advocate Commissioner to conduct survey. Since the representation is already made, all the above aspects shall be considered while considering the representation dated 17.12.2024 by the competent respondent.
