ORDER

This writ petition has been filed seeking a direction to the 2nd respondent to survey and fix the boundaries pertaining to the land bearing survey No.289/10(part) of Panchalanguruchi Revenue Village, Ottapidaram Taluk, Thoothukudi District as per the registered sale deed measurement, within the time limit as fixed by this Court based on the petitioner application, dated 18.03.2025.

2. Heard the learned counsel for the petitioner and learned Additional Government Pleader for the respondents.

3. The learned counsel for the petitioner would submit that the representation made survey and to fix boundaries of the land in question has not been acted upon.

4. Learned Additional Government Pleader would submit that representation of the petitioner's would be considered by the respondents within a considerable time fixed by this Court.
