2. The petitioner has sent a representation on 05.04.2022, seeking to rectify the wrong entries shown in respect of the petitioner's property in the TSLR and FMB records. After receipt of the same, the first respondent issued a direction to the 2<sup>nd</sup> respondent to conduct an enquiry and file a report for taking further action. But the 2<sup>nd</sup> respondent did not take any action till date. Hence, the petitioner has filed this Writ Petition.

3. The learned Government Advocate appearing for the respondents 1 and 2 would submit that the representation of the petitioner dated 05.04.2022 would be considered in accordance with law.

4. In view of the same, without expressing any opinion on the merits of the matter, this Court directs the respondents to consider and pass orders on the representation of the petitioner dated 05.04.2022 on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order.
