ORDER

This writ petition has been filed to direct the respondents to consider petitioners representation dated 14.07.2023.

The learned counsel for the petitioner would submit that in this case, the petitioner has given a representation dated 14.07.2023 requesting the respondents to grant permission for construct a new temple building in the Survey No.860/13 to an extent of 1 cent out of 5 cents situated in Gandhiji Street, A.Vallalapatti, Melur Taluk, Madurai District. However, the said representation was not at all considered by the respondent till date. Hence, this petition.
