ORDER

Challenging the order dated 07.07.2018 passed by the second respondent, the present writ petition has been filed by the petitioner.

2. Heard the learned counsel for the parties and perused the materials on record.

Though the petitioner claimed right over the subject property in Survey Nos. 152/11A and 152/11B, he failed to establish the same by producing the requisite documents before the second respondent/District Revenue Officer. Consequently, the revision petition was dismissed and that the parties were directed to approach the competent Civil Court

within 90 days. However, the petitioner chose to file the present writ petition belatedly and nearly seven years have elapsed since the passing of the impugned order. In view of the inordinate delay and the disputed nature of the claim, this Court is not inclined to interfere with the impugned order. Accordingly, the writ petition stands disposed of. No costs. Consequently, the connected miscellaneous petitions are closed.
