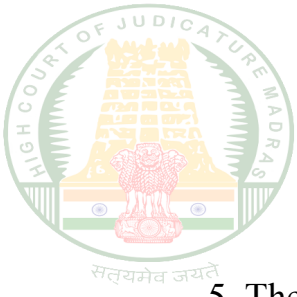

ORDER

The petitioner assails the work order dated 09.08.2024 issued by the first respondent in favour of the 6th respondent.

2. In the said work order, the 6th respondent was permitted to execute the work for supply of drinking water.

3. Learned Government Advocate for the respondents 2 and 3 submitted that the impugned work order was issued on 09.08.2024 and the writ petition was filed on 03.09.2024 by which time the 6th respondent had completed the work entrusted to him.

4. The work order was issued on 09.08.2024 and the writ petition was filed on 03.09.2024 by which time, the 6th respondent had commenced the work and completed the work satisfactorily as of today. The petitioner has also stated the violation of any provisions of the Tamil Nadu Transparency in Tenders Act, 1998.

5. Therefore, in light of the above, the relief sought for in this writ petition does not survive for further adjudication.
