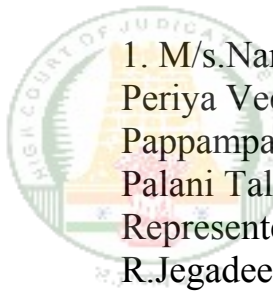

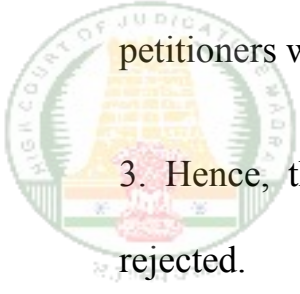
Prayer: Petition filed under Section 151 of the Civil Procedure code, to grant permission to the petitioners above named to file the above Writ Appeal and thus render justice.
