3. The learned counsel appearing for the petitioner would submit that representations had been made on 25.11.2019 and 07.12.2019 for survey and demarcation of the boundaries of the subject property.

4. The learned Special Government Pleader appearing for the respondents submits that after considering the claims of all parties, proper steps would be taken to survey and demarcate the land in accordance with Sections 9 and 10 of the Tamil Nadu Land Survey and

Notice shall be issued to the petitioner and the owners of relevant adjacent lands and appropriate orders shall be passed in accordance with Sections 9 and 10 of the Tamil Nadu Land Survey and Boundaries Act 1923, within a period of eight weeks from today. In the event of any rival claims, the same can be agitated before the competent civil court. No costs.
