2. When the matter was taken up for hearing, the learned counsel for the petitioner confined his prayer to a direction to the first respondent to dispose of the petitioner's representation dated 06.01.2020 within the time frame to be fixed by this Court.

3. In response, learned Additional Government Pleader appearing for the respondents submitted that the representation of the petitioner will be considered and disposed of on merits by the first respondent in accordance with law, within the time frame stipulated by this Court.

4. In view of the above submissions, without expressing any opinion on the merits of the matter, this writ petition is disposed of with a
