ORDER

The petitioner herein filed W.P.(MD)No.1370 of 2017 for directing removal of the encroachment in S.No.1420/1. Vide order dated 30.01.2017, the authority was directed to remove all the encroachments. Pursuant to the said order, the authority concerned issued the eviction orders. They were challenged in a batch of writ petitions and interim order of status quo was granted. Therefore, the authority was unable to take consequential action.

2. Today we have dismissed all those writ petitions. Hence, there is no impediment for the authority concerned to take further action in the matter.
