ORDER

This Writ Petition has been filed challenging the impugned order passed by the second respondent in Application No.2 of 2016, dated 28.07.2017 and to direct the respondents 1 and 2 to refuse registration of the 4th respondent's document.

2. The learned counsel appearing for the petitioner would submit that, in the present case, the fourth respondent's application for registration of sale deed was allowed by the second respondent on 28.07.2017, without considering the objections made by the petitioner. Subsequent to the above order, the fourth respondent's sale deed was also registered by the third respondent. According to the learned counsel, such registration is in violation of the interim stay already granted by this Court on 11.09.2017.

3. In view of the registration of the fourth respondent's sale deed, the prayer sought for in this Writ Petition has become infructuous. Therefore, this Writ Petition is dismissed as infructuous. If the petitioner feels that there
