ORDER

This writ petition has been filed for a mandamus directing the respondents to award compensation due to the death of the petitioner's husband Mr.Jeyaganesan Perumal in a road accident met at the Country of Saudi Arabia in furtherance of proceedings of the respondents 4 and 5 initiated in File No.RIY/CW/436/390/2016 dated 29.05.2022 within a stipulated time that may be fixed by this Court.

2. Heard the learned counsel for the petitioner, the learned Special Government Pleader for the respondent 6 to 8 and the learned counsel for the respondents 1 to 3.

3. The learned counsel for the petitioner would submit that the petitioner made a representation to the respondents seeking for compensation for the death of her husband in a road accident at Saudi Arabia, pursuant to the proceedings initiated by the respondents 4 and 5 dated 29.05.2022. However, since the said representation has not been considered so far, the petitioner is before this Court.

4. The learned Special Government Pleader and the learned counsel for the respondents would submit that on considering the representation of the petitioner, necessary orders would be passed by the respondents 4 and 5.

Considering the said submission made, the writ petition is disposed of by directing the respondents 4 and 5 to consider the claim made by the petitioner and pass orders on merits and in accordance with law as expeditiously as possible, preferably within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
