ORDER

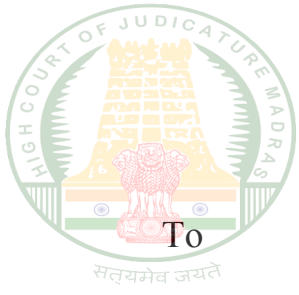
