**ORDER**

The petitioner, an accused in Spl.S.C.No.20 of 2018, on the file of the Special Court for Exclusive trial of Cases under POCSO Act, Kanniyakumari at Nagercoil was found guilty by the trial Court

and was convicted and sentenced as under:-

| Sl.No | Sections                | Punishment                     | Fine amount | Default                      |
|-------|-------------------------|--------------------------------|-------------|------------------------------|
| 1.    | 5(m) r/w 6 of POCSO Act | 20 years Rigorous imprisonment | Rs.10,000/- | 6 months simple imprisonment |
| 2.    | 449 IPC                 | 10 years Rigorous Imprisonment | Rs.5,000/-  | 6 months simple imprisonment |
| 3.    | 506(i) IPC              | 2 years Rigorous Imprisonment  | -           | -                            |

As against the conviction and sentence imposed by the trial Court in S.C.No.20 of 2018, dated 17.11.2022, the petitioner has filed a Criminal Appeal in Crl.A(MD) No.99 of 2024 and the same has been admitted by this Court on 07.02.2024. The petitioner has already filed a petition in CrlMP(MD)No.1379 of 2024 to suspend the sentence imposed on him by the trial Court and it has been dismissed by this court considering the gravity of the offence. This court while dismissing the said petition, directed the Registry to list the Criminal Appeal for final disposal.
